The forecourt price! This is the price you would be expected to pay any vehicle trader or dealer! In order to get warranty with any vehicle sold! This is as you would expect if you are buying from a vehicle trader or dealer!. You are expected to pay the full forecourt price under these terms for a warranty with a vehicle sold.

Private & Trade Price

Private & Trade Price (Low Standards & Will Have Some Major Or Minor Issues)

Private & Trade Price (Price to clear with low standards & will have some major or minor issues)

Anything sold in this category! The vehicle is not up to a good standard & will have some major or minor issues, There is *No warranty & there will be *No negotiation on the final price. Cash or bank transfer payments only.

---Sold As Trade---

Anyone can purchase a trade vehicle in this category as long as they understand & rectify any issues. The vehicle must be fully fixed by you before retailing it! (Selling it on) Or passing the vehicle on to someone without this knowledge.

#The vehicle will be sold with major defects.

#The vehicle will be sold with minor defects.

#The vehicle will be sold with bodywork issues.

#The vehicle will be sold with Interior issues.

Deposit of £100 non-refundable – We must have full payment or a payment contract in place & collected within 7 days. If full payment or a payment contract hasn't been agreed within the stated period the vehicle will be re-advertised & any deposit previously paid is non-refundable.

Delivered

Delivered (Ref: To Terms Of Delivery)

Delivery £2.00 per mile one way! So example if you live 25 miles away delivery is £50.00 etc. To secure a vehicle and arrange to be delivered is 20% deposit plus delivery cost (Non-returnable) as a bank transfer and the balance on delivery!, Balance payment by Cash or Bank Transfer. If the price of the vehicle has been renegotiated!, Then there will be a starting charge of £90.00 on top (You can't beat the price down and then ask us to delivery it for any less). We don't travel into the centre of London or anywhere where there is a low emission zone or congestion charge. We may still ask to see some form if I:D on the day. (Ref: To Terms Of Delivery).

Return within 14 business days or 1000 miles (This includes Sundays & Bank Holidays) The vehicle must not exceed more than 1000 miles, Vehicle must be returned in the same condition as sold. If you break it! You fix it, If you damage it! No returns accepted. It's at our discretion if we want to accept any returns!, If we don't feel that it is justified, Then we won't accept any returns. Any returns are down to you and you are responsible to return the vehicle to us at our location. We will charge you for the use of the vehicle for the period at £42 per day. If you have part exchanged a vehicle!, The balance on your part exchange vehicle will only be paid back for the part exchange value, Your part exchange vehicle will not be returned.

Any returns are down to you and you are responsible to return the vehicle to us at our location. If you have a part exchange vehicle, This will be returned to you.

Return within 1 hour or 50 miles. The vehicle must not exceed more than 50 miles. If you break it! You fix it, If you damage it! No returns accepted. Any returns are down to you and you are responsible to return the vehicle to us at our location. If you have a part exchange vehicle, This will be returned to you.

You Have A Duty Of Care – Basic Maintenance Required

You have a duty of care for any vehicle sold under the category of Forecourt (Retail). To extend the life of the vehicle you are responsible to keep up with the maintenance of the vehicle by checking the fluid levels at least 3 times a week for the first few weeks, followed by every 5 days thereafter. A full service is required each year i.e. changing the engine oil / coolant & air filter at the bare minimum. We not only recommend, But insist that you take pictures of this maintenance work if you are carrying the work out by yourself, Or keep any receipts/garage bills for future references. You will be required to show evidence of the fluid levels being check whilst the vehicle has a current warranty in place (Check your warranty agreement). Once your warranty expires you are still expected to perform basic maintenance on your vehicle.

We not only recommend, But insist that you take pictures of this maintenance work if you are carrying the work out by yourself, Or keep any receipts/garage bills for future references.

Firstly - Some Important Facts

Forecourt Price (Retail Price)

If you pay the full forecourt price you will get a 30 day warranty or a 90 day warranty! And this will depend on the age of the vehicle. This information will be clearly laid-out in your sale agreement. There is *No warranty issued without the full forecourt price being received.

Timing Belt

Timing belts are a perishable part!, If it was advised to have this changed upon the sale of the vehicle and this was neglected to be done by you, Then this perishable part is not covered by any warranty by neglect.

If the part was replaced by us or during the last keeper and the part is still well within its time and date and mileage period, Then we will honor warranty cover on this part, *But only!!!, Under these terms!!!, As it would have NOT been expected to fail due to this. **If there is No history!, No paperwork!, Then No warranty will apply!.

Just Used Cars: Hereby is to accept any warranty claims / liability for the following items for the agreed period to a maximum of 1 x claim per item only and to a maximum overall cost of £1,200 during this period.

1 x Claim on Engine Block, Which Includes – {Engine Block, Head Gasket & Timing Chain Failure}.

1 x Claim on Gearbox Failure, Which Involves – {Forward & Reverse Motion Failure Only}.

If the vehicle is unable to move under its own power, Your vehicle will be recovered by us within the UK mainland at £120.00 starting fee, Plus £2.30 per mile (One way) we have to travel. All warranty work is to be carried out by us (Just Used Cars) and by us only. If the vehicle is touch by anyone else or parts removed! This will forthwith withdraw any warranty claim made against us (Just Used Cars). *If you wrongly diagnose or suspect and call us out for a warranty issue you will be charged £120.00 call out fee, Plus £2.30 per mile (One way) we have to travel. Alternately use any breakdown recovery service i.e. AA, RAC, Green Flag.
